## **Hawaiian Airlines FCU Has Merged with Hawaiian Tel FCU**

We are very pleased to announce that the membership of Hawaiian Airlines FCU (HALFCU) has recently voted overwhelmingly in favor of merging with Hawaiian Tel FCU. That merger has also received the blessings of the regulatory agencies that oversee both credit unions. As a result, 3,000+ HALFCU members officially became HiTel members on November 1, 2017. On February 5, 2018, all account holders will be able to transact at the 10 Hawaiian Tel FCU branches and hundreds of Shared Branching locations nationwide.

This is truly an exciting development for HiTel's existing members as well as those who have joined our HiTel family as a result of this merger.

For these former HALFCU members, the merger means access to a more robust branch network with convenient service hours, the availability of more products and services, more favorable rates and fees, and other membership perks. For existing HiTel members, it means your credit union is strong and growing.



## BEING A FRAUDBUSTER NEVER ENDS

Fraudsters and identity thieves never take a holiday. They're as sharp as ever, looking for every opportunity to snatch up your information. HiTel FCU helps guard against fraud as best we can, but the steps you can take are equally important.

Be vigilant with your information during the holiday season. Watch out for deals that seem too good to be true and always verify a deal's legitimacy before giving your information. When in doubt, withhold.

Additionally, you should always keep your information up to date with your financial institutions so they can notify you as soon as they detect fraud on your accounts. If they find something suspicious but cannot contact you, they will not be able to confirm that it is fraud, and your accounts will suffer for it.

Be a savvy Fraudbuster. Keep your information safe, especially during the holidays.
